(the “Company”), reported herein are held by RTW Master Fund, Ltd. and one or more other funds (together the “Funds”), which are managed by RTW Investments, LP (the “Adviser”). The Adviser, in its capacity as the investment manager of Funds, has the power to vote and the power to direct the disposition of all Shares held by the Funds. Accordingly, for the purposes of Reg. Section 240.13d-3, the Adviser may be deemed to beneficially own an aggregate of 3,841,226 Shares, or 6.1% of the Shares issued and outstanding as of October 31, 2018. Roderick Wong is the Managing Partner of the Adviser. The beneficial ownership percentage reported herein is based on 62,868,379 Shares issued and outstanding as of October 31, 2018, as disclosed in the Company’s most recent Form 10-Q, as filed with the Securities and Exchange Commission on November 8, 2018.
